#### Key Statements from the Discussion

- Environmental issues are now moving to a central stage, strong policies are being implemented for Renewables (RES) and Energy Efficiency (EE), also thanks to the Green Deal.
- •EU that connects is a priority.
- Focus on activities and measures for reduction of emissions and the development of a low carbon economy.
- Focus on the fair energy transition and defining additional elements such as region cooperation, a very important element from the Governance.
- Work on a framework for Clean Energy on EU islands- Valletta declaration.
- •In the energy charter, focus on the process of modernization.




